# **Updated Information**

Menard County Housing Authority MUST ALWAYS have all of your information up to date.

- Please contact the office to report a change in phone number immediately in case of emergency. If you do not have a phone, please provide us with a message number.
- If your emergency contact's information has changed, please report it to us as soon as possible.
- It is to your benefit to report any income changes when they happen. Failure to provide this information to MCHA is considered fraud.
- Report any other changes when they happen, such as marriage, divorce, and changes in occupancy of the household. Failure to report new persons living in the unit is grounds for eviction.
- Contact the office as soon as possible if you obtain a pet. Documentation and a pet fee are required

## Kindergarten Pre-Registration for 2020-2021 & Pre-K Screenings

Children who will be five years old by September 1, 2020 are eligible to attend kindergarten this fall. If you know of someone who has a child that will be eligible for kindergarten, please ask them to contact Petersburg Elementary (632-7731) by February 28th. Parents/guardians of students enrolled in PORTA's preschool programs (pre-k & early childhood), who are kindergarten eligible, will soon be receiving a form to be completed and returned to the school office. Our spring pre-k screenings have been set for March 17th & 18th. Call the Elementary office to schedule a screening if you have a child who is at least 2 1/2 years of age. Also, please spread the word to anyone in our district who has a child in need of screenings. A screening must be done to determine eligibility for Pre-K.
